

Performance summary:

- 54,680 participants (excluding children accessing early connections) have had an approved plan since July 2013. 51,072 of these continue to be active.
- 35,552 active participants have not previously received disability support via State and Commonwealth government programs in the past.
- In the current quarter, 1,655 participants have entered the Scheme and there are 1,071 children accessing early connections at the end of March 2023.
- 7,052 plans have had reassessments this quarter.
- 2,247 access decisions have been made in the quarter, of which 1,720 met access and are still active.
- 143 (8.7%) of the new active participants this quarter identified as First Nations participants, taking the total number of First Nations participants in SA to 3,215 (6.3%).
- 109 (6.6%) of the new active participants this quarter are Culturally and Linguistically Diverse (CALD) ³, taking the total number of CALD participants in SA to 3,676 (7.2%).





- Total annualised plan budgets at 31 March 2023 were \$3,675m and payments from 1 July 2022 were \$2,163m.
- The number of active providers at the end of March is 3,068, growing by 5% in the quarter.
- Utilisation has been 76% from 1 July 2022 to 31 December 2022, with 17% (2 out of 12) of service districts in South Australia more than 10 percentage points below the adjusted national benchmark.
- There were no service districts where the top 10 providers provide more than 70% of payments.

Service districts more than 10% below plan utilisation benchmark:

- Eyre and Western: 62% vs 73% benchmark
- Far North (SA): 63% vs 75% benchmark

Service districts closest to market concentration benchmark:

- Far North (SA): 63% vs 70% benchmark
- Limestone Coast: 59% vs 70% benchmark
- Murray and Mallee: 54% vs 70% benchmark
- Yorke and Mid North: 43% vs 70% benchmark
- Eyre and Western: 43% vs 70% benchmark

¹ Active providers refer to those who have received payment for supports provided to Agency-managed participants and plan managers.

² The 'benchmark' in this analysis is the national average after adjusting for the proportion of participants in Supported Independent Living (SIL) in each service district and the length of time participants have been in the Scheme.


³ Total annualised plan budgets refer to those in the current plans of active participants at the end of quarter.

⁴ Total plan inflation consists of plan budget changes occurring at plan reassessment as well as changes occurring within a plan between reassessments.


⁵ Socioeconomic status uses deciles from the ABS Index of Education and Occupation (IEO). A higher decile indicates that people residing in that area have a higher level of skills and qualifications on average. The socioeconomic equity metric is equal to the average annualised plan budget of participants residing in the top two IEO deciles divided by the average annualised plan budget of participants residing in the bottom two IEO deciles (participants not in SIL and aged 0 to 64).

- Northern Adelaide has the highest number (17,366) of active participants, while Far North (SA) has the lowest (558).
- The average annualised plan budget at the end of March for active participants is \$72,000 (\$51,400 for participants not in SIL and \$411,200 for participants in SIL).
- The average payment for the 12 months ending 31 March 2023 is \$57,900 (\$37,400 for participants not in SIL and \$404,900 for participants in SIL).
- Eastern Adelaide has the highest average annualised plan budgets and payments across all participants.

¹ There are 40 active participants at 31 March 2023 residing in 'Other' service districts. 'Other' includes participants with service district information missing. The average annualised plan budgets and average payments for this group are not shown.

² Figures are not shown if there is insufficient data in the service district.

³ Average annualised plan budgets are derived from total annualised plan budgets in the current plans of active participants at 31 March 2023. Average payments are derived from total payments paid over the 12 months to 31 March 2023, divided by the average number of active participants between the start and end of the 12 months.
