

#### Performance summary:

- 6,350 participants (excluding children accessing early connections) have had an approved plan since July 2013. 5,838 of these continue to be active.
- 3,798 active participants have not previously received disability support via State and Commonwealth government programs in the past.
- In the current quarter, 242 participants have entered the Scheme and there are 105 children accessing early connections at the end of September 2023.
- 699 plans have had reassessments this guarter.
- 309 access decisions have been made in the quarter, of which 242 met access and are still active.
- 115 (47.7%) of the new active participants this quarter identified as First Nations participants, taking the total number of First Nations participants in Northern Territory to 2,950 (50.5%).
- 11 (4.6%) of the new active participants this quarter are Culturally and Linguistically Diverse (CALD) 4, taking the total number of CALD participants in Northern Territory to 354 (6.1%).

This change will occur over the next two years and ensures children and their families are supported by an early childhood partner during and after their transition to primary school. This is a change from the June 2023 quarter, where the early childhood approach applied to children younger than seven.

The NDIA commenced measuring performance against the PSG metrics prior to the legislation of the Participant Service Charter and Guarantee. On 30 March 2022, the NDIS Amendment (Participant Service Guarantee and Other Measures) Bill 2021 passed in both houses of Parliament, and received Royal Assent on 1 April 2022. It introduces changes that provide greater flexibility for participants and the NDIA to amend plans.

- Total annualised plan budgets at 30 September 2023 were \$707m and payments from 1 July 2023 were \$151m.
- The number of active providers at the end of September is 1,078, growing by 3% in the guarter.
- Utilisation has been 77% from 1 January 2023 to 30 June 2023, with 33% (2 out of 6) of service districts in Northern Territory more than 10 percentage points below the adjusted national benchmark.
- In 33% (2 out of 6) of service districts, the top 10 providers provide more than 70% of payments.



## Service districts more than 10% below plan utilisation benchmark:

- East Arnhem: 51% vs 75% benchmark
- Darwin Remote: 60% vs 71% benchmark

#### Service districts above the market concentration benchmark:

- · Katherine: 79% vs 70% benchmark
- · Barkly: 77% vs 70% benchmark




<sup>&</sup>lt;sup>7</sup> Socioeconomic status uses deciles from the ABS Index of Education and Occupation (IEO). A higher decile indicates that people residing in that area have a higher level of skills and qualifications on average. The socioeconomic equity metric is equal to the average annualised plan budget of participants residing in the top two IEO deciles divided by the average annualised plan budget of participants residing in the bottom two IEO deciles (participants not in SIL and aged 0 to 64).




■ Active participants by service district as at 30 September 2023

- Darwin Urban has the highest number (3,466) of active participants, while Barkly has the lowest (149).
- The average annualised plan budget at the end of September for active participants is \$121,200 (\$67,100 for participants not in SIL and \$625,900 for participants in SIL).
- The average payments for the 12 months ending 30 September 2023 are \$102,700 (\$52,400 for participants not in SIL and \$583,100 for participants in SIL).
- Central Australia has the highest average annualised plan budgets and payments across all participants.
