

Performance summary:

- 101,096 participants (excluding children accessing early connections) have had an approved plan since July 2013. 97,475 of these continue to be active.
- 54,646 active participants are receiving supports for the first time.
- In the current quarter, 5,069 participants have entered the Scheme and there are 3,712 children accessing early connections at the end of September 2021.
- 18,979 plans have been reviewed this quarter.
- 6,846 access decisions have been made in the quarter, of which 5,240 met access and are still active.
- 518 (10.2%) of the new active participants this quarter identified as Indigenous, taking the total number of Indigenous participants in QLD to 9,295 (9.5%).
- 297 (5.9%) of the new active participants this quarter are Culturally and Linguistically Diverse (CALD) ³, taking the total number of CALD participants in QLD to 5,263 (5.4%).



- Total annualised plan budgets at 30 September 2021 were \$7,002m and payments from 1 July 2021 were \$1,422m.
- The number of active providers at the end of September is 6,321, growing by 4% in the quarter.
- Utilisation was 74% from 1 January 2021 to 30 June 2021, with no service district in Queensland more than 10 percentage points from the adjusted national benchmark.
- In no service districts the top 10 providers provide more than 85% of payments.







• Brisbane has the highest number (18,209) of active participants, while Bundaberg has the lowest (2,845).

Average payments for 12 months to 30 September 2021

- The average annualised plan budget at the end of September for active participants is \$71,800 (\$56,900 for participants not in SIL and \$351,800 for participants in SIL).
- The average payment for the 12 months ending 30 September 2021 is \$59,200 (\$42,900 for participants not in SIL and \$348,300 for participants in SIL).
- Cairns has the highest average annualised plan budgets and payments across all participants.

¹ There are 24 active participants at 30 September 2021 residing in 'Other' service districts. 'Other' includes participants with service district information missing. The average annualised plan budgets and average payments for this group are not shown.
