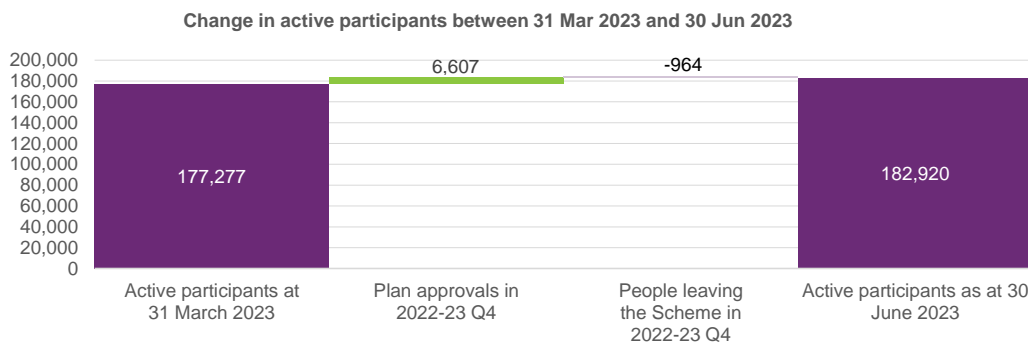

Performance summary:

- 196,692 participants (excluding children accessing early connections) have had an approved plan since July 2013. 182,920 of these continue to be active.
- 118,724 active participants have not previously received disability support via State and Commonwealth government programs in the past.
- In the current quarter, 6,607 participants have entered the Scheme and there are 6,071 children accessing early connections at the end of June 2023.
- 20,492 plans have had reassessments this quarter.
- 9,380 access decisions have been made in the quarter, of which 7,023 met access and are still active.
- 755 (11.4%) of the new active participants this quarter identified as First Nations participants, taking the total number of First Nations participants in New South Wales to 15,741 (8.6%).
- 728 (11.0%) of the new active participants this quarter are Culturally and Linguistically Diverse (CALD) ³, taking the total number of CALD participants in New South Wales to 19,965 (10.9%).

• The PSG metrics are based on the recommendations of the 2019 Tune Review. The NDIA commenced measuring performance against the PSG metrics prior to the legislation of the Participant Service Charter and Guarantee. On 30 March 2022, the NDIS Amendment (Participant Service Guarantee and Other Measures) Bill 2021 passed in both houses of Parliament, and received Royal Assent on 1 April 2022. It introduces changes that provide greater flexibility for participants and the NDIA to amend plans.

¹ PSG results in the previous quarter may be restated due to ongoing logic refinement and changes in data quality.

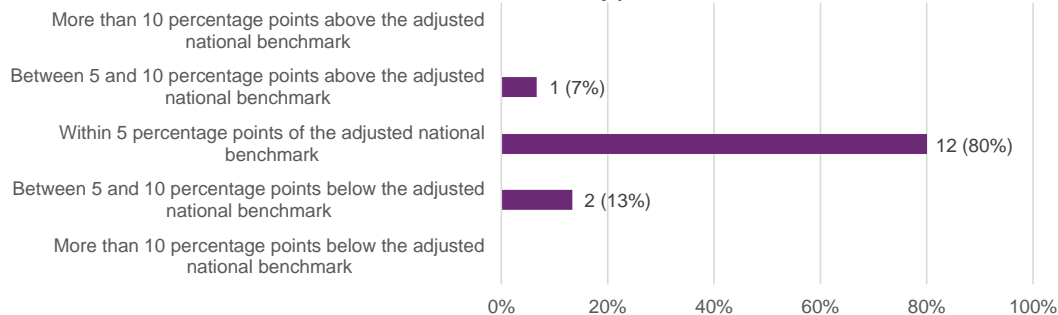

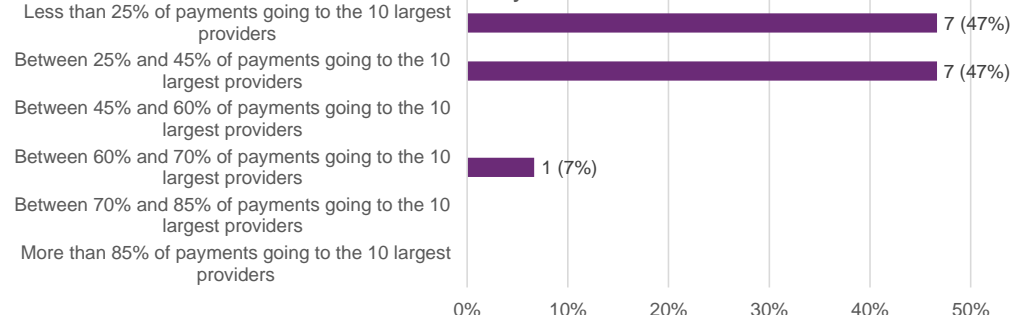

- Total annualised plan budgets at 30 June 2023 were \$13,885m and payments from 1 July 2022 were \$10,897m.
- The number of active providers at the end of June is 10,408, growing by 2% in the quarter.
- Utilisation has been 78% from 1 October 2022 to 31 March 2023, with no service districts in New South Wales more than 10 percentage points below the adjusted national benchmark.
- There were no service districts where the top 10 providers provide more than 70% of payments.

Service districts between 5% and 10% below plan utilisation benchmark:

- Far West: 66% vs 74% benchmark
- Western NSW: 69% vs 77% benchmark

Service districts having between 45% and 70% of payments going to the top 10 providers:

¹ Active providers refer to those who have received payment for supports provided to Agency-managed participants and plan managers.

² The 'benchmark' in this analysis is the national average after adjusting for the proportion of participants in Supported Independent Living (SIL) in each service district and the length of time participants have been in the Scheme.

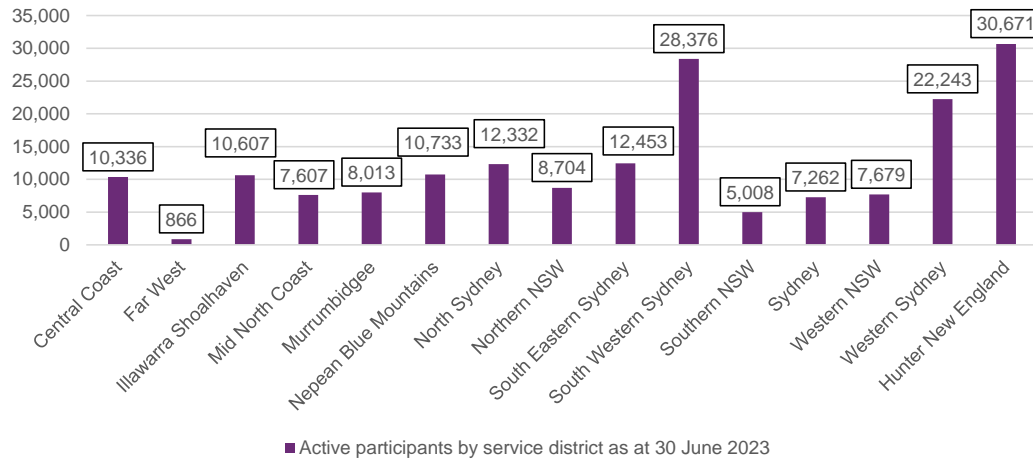
³ Total annualised plan budgets refer to those in the current plans of active participants at the end of quarter.

⁴ Total plan inflation consists of plan budget changes occurring at plan reassessment as well as changes occurring within a plan between reassessments.

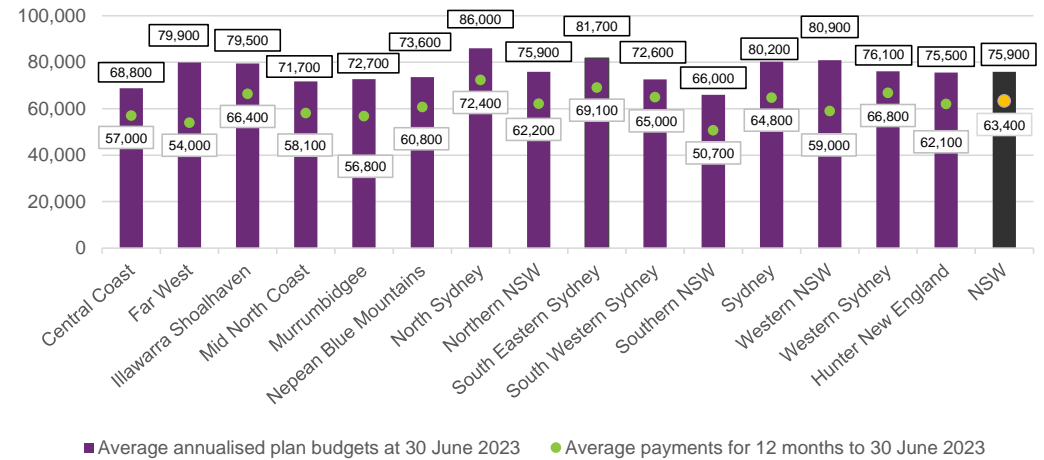
⁵ Socioeconomic status uses deciles from the ABS Index of Education and Occupation (IEO). A higher decile indicates that people residing in that area have a higher level of skills and qualifications on average. The socioeconomic equity metric is equal to the average annualised plan budget of participants residing in the top two IEO deciles divided by the average annualised plan budget of participants residing in the bottom two IEO deciles (participants not in SIL and aged 0 to 64).

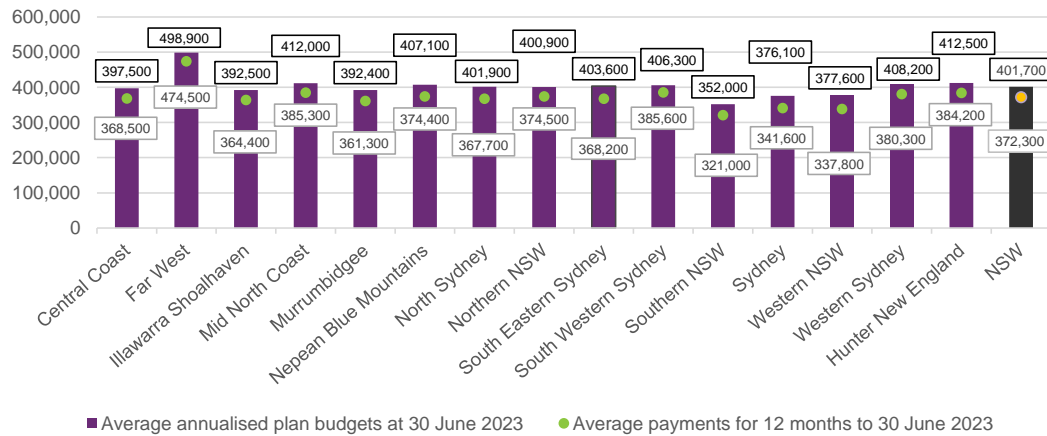
Active participants by service district ¹



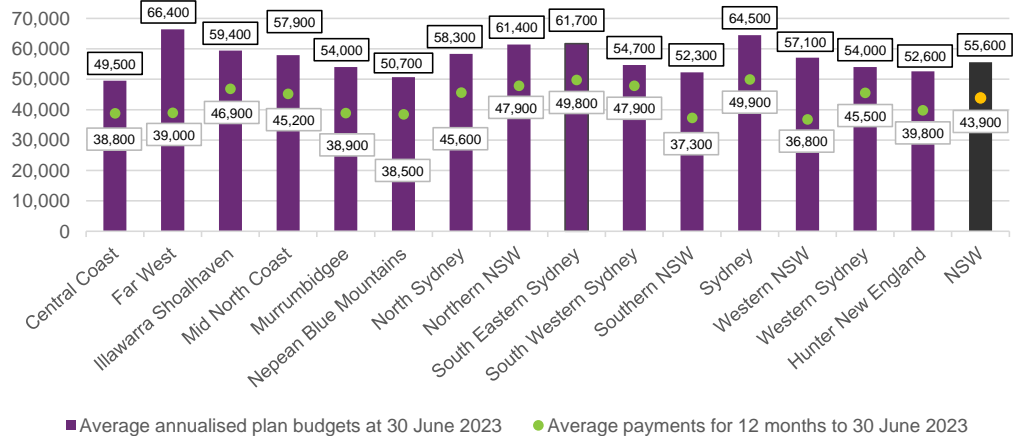
Average annualised plan budgets and average payments (\$) ^{2 3}

- Hunter New England has the highest number (30,671) of active participants, while Far West has the lowest (866).
- The average annualised plan budget at the end of June for active participants is \$75,900 (\$55,600 for participants not in SIL and \$401,700 for participants in SIL).
- The average payment for the 12 months ending 30 June 2023 is \$63,400 (\$43,900 for participants not in SIL and \$372,300 for participants in SIL).
- North Sydney has the highest average annualised plan budgets and payments across all participants.

¹ There are 30 active participants at 30 June 2023 residing in 'Other' service districts. 'Other' includes participants with service district information missing. The average annualised plan budgets and average payments for this group are not shown.

² Figures are not shown if there is insufficient data in the service district.

³ Average annualised plan budgets are derived from total annualised plan budgets in the current plans of active participants at 30 June 2023. Average payments are calculated as the average of the annualised monthly payments in the same 12 month period, weighted by the participants that are active in each month.
