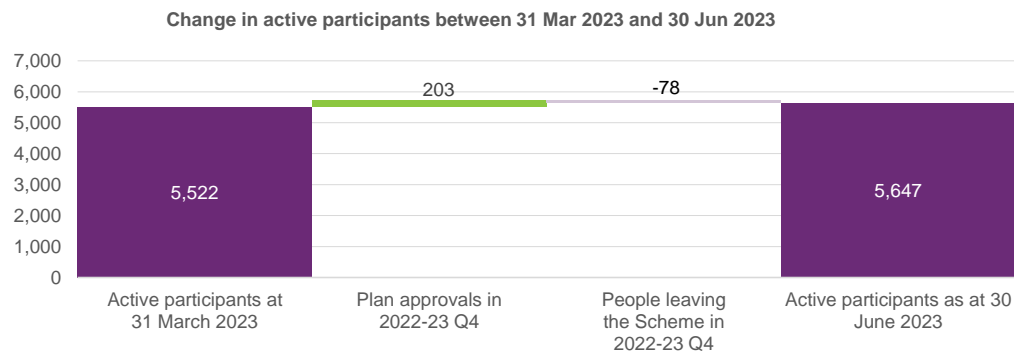

**Performance summary:**

- 6,128 participants (excluding children accessing early connections) have had an approved plan since July 2013. 5,647 of these continue to be active.
- 3,598 active participants have not previously received disability support via State and Commonwealth government programs in the past.
- In the current quarter, 203 participants have entered the Scheme and there are 132 children accessing early connections at the end of June 2023.
- 788 plans have had reassessments this quarter.
- 248 access decisions have been made in the quarter, of which 204 met access and are still active.
- 98 (48.3%) of the new active participants this quarter identified as First Nations participants, taking the total number of First Nations participants in Northern Territory to 2,854 (50.5%).
- 17 (8.4%) of the new active participants this quarter are Culturally and Linguistically Diverse (CALD) <sup>3</sup>, taking the total number of CALD participants in Northern Territory to 355 (6.3%).

• The PSG metrics are based on the recommendations of the 2019 Tune Review. The NDIA commenced measuring performance against the PSG metrics prior to the legislation of the Participant Service Charter and Guarantee. On 30 March 2022, the NDIS Amendment (Participant Service Guarantee and Other Measures) Bill 2021 passed in both houses of Parliament, and received Royal Assent on 1 April 2022. It introduces changes that provide greater flexibility for participants and the NDIA to amend plans.

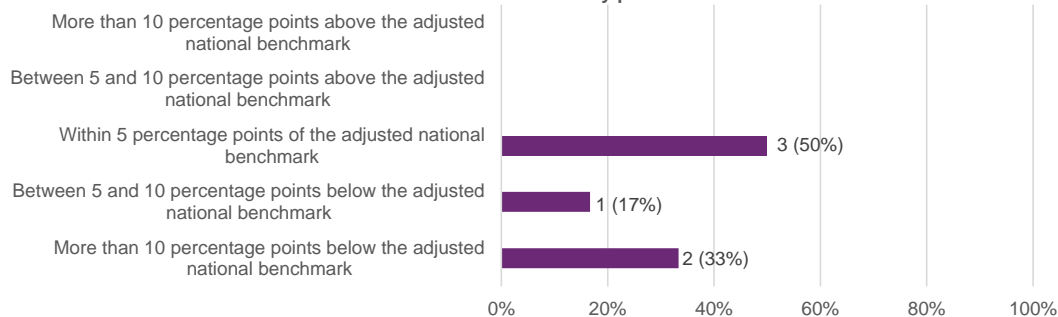

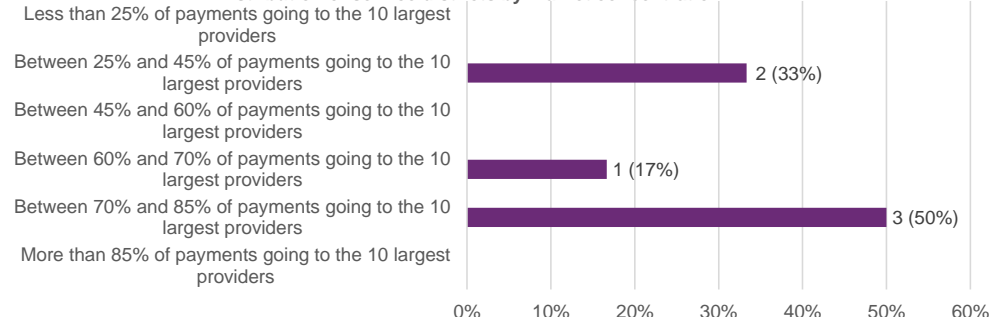

- Total annualised plan budgets at 30 June 2023 were \$664m and payments from 1 July 2022 were \$535m.
- The number of active providers at the end of June is 1,044, remaining at the same level as last quarter.
- Utilisation has been 76% from 1 October 2022 to 31 March 2023, with 33% (2 out of 6) of service districts in Northern Territory more than 10 percentage points below the adjusted national benchmark.
- In 50% (3 out of 6) of service districts, the top 10 providers provide more than 70% of payments.

**Service districts more than 10% below plan utilisation benchmark:**

- East Arnhem: 52% vs 74% benchmark
- Darwin Remote: 57% vs 69% benchmark

**Service districts above the market concentration benchmark:**

- Katherine: 79% vs 70% benchmark
- Barkly: 76% vs 70% benchmark
- East Arnhem: 73% vs 70% benchmark

<sup>2</sup> The 'benchmark' in this analysis is the national average after adjusting for the proportion of participants in Supported Independent Living (SIL) in each service district and the length of time participants have been in the Scheme.

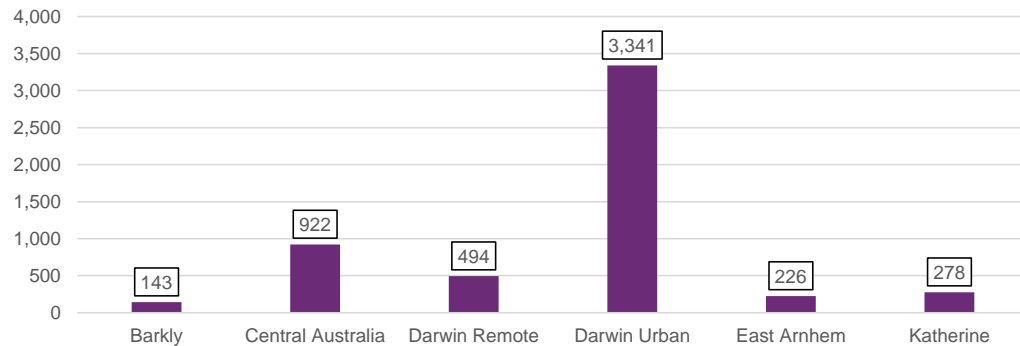
<sup>3</sup> Total annualised plan budgets refer to those in the current plans of active participants at the end of quarter.

<sup>4</sup> Total plan inflation consists of plan budget changes occurring at plan reassessment as well as changes occurring within a plan between reassessments.

<sup>5</sup> Socioeconomic status uses deciles from the ABS Index of Education and Occupation (IEO). A higher decile indicates that people residing in that area have a higher level of skills and qualifications on average. The socioeconomic equity metric is equal to the average annualised plan budget of participants residing in the top two IEO deciles divided by the average annualised plan budget of participants residing in the bottom two IEO deciles (participants not in SIL and aged 0 to 64).

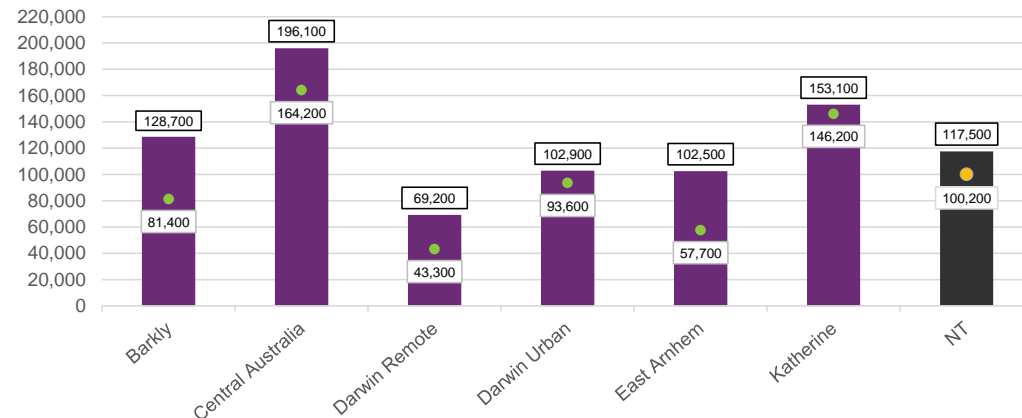

Active participants by service district <sup>1</sup>



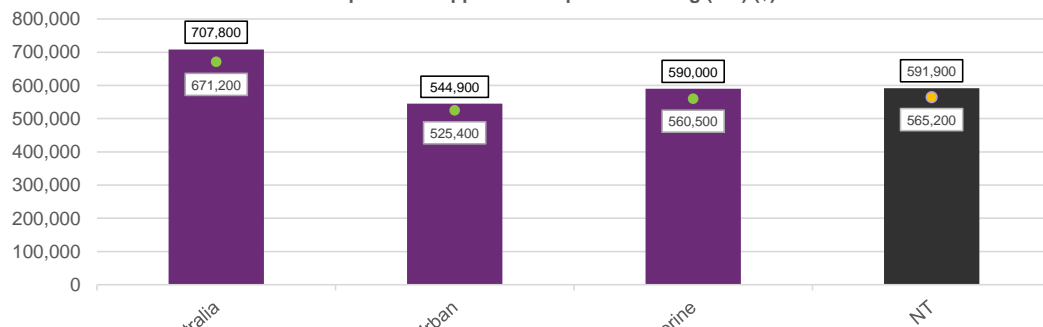
Active participants by service district as at 30 June 2023

Average annualised plan budgets and average payments (\$) <sup>2 3</sup>



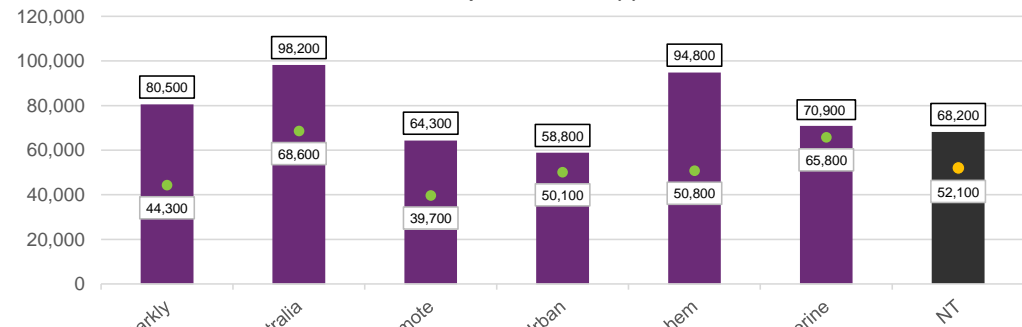
Average annualised plan budgets at 30 June 2023 Average payments for 12 months to 30 June 2023

- Darwin Urban has the highest number (3,341) of active participants, while Barkly has the lowest (143).
- The average annualised plan budget at the end of June for active participants is \$117,500 (\$68,200 for participants not in SIL and \$591,900 for participants in SIL).
- The average payment for the 12 months ending 30 June 2023 is \$100,200 (\$52,100 for participants not in SIL and \$565,200 for participants in SIL).
- Central Australia has the highest average annualised plan budgets and payments across all participants.
