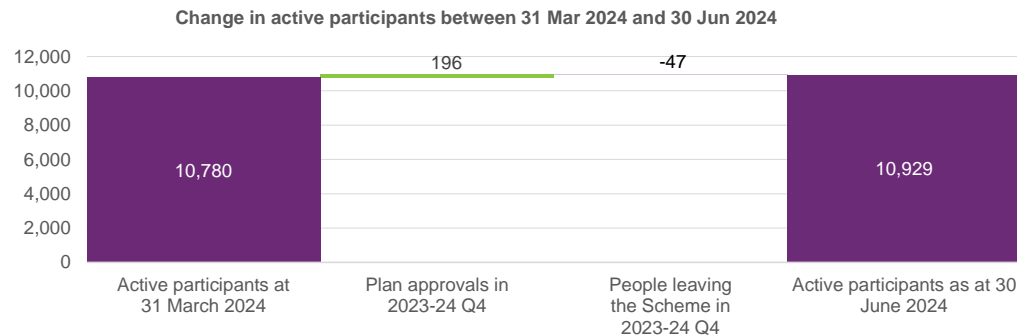

**Performance summary:**

- 12,666 participants (excluding children accessing early connections) have had an approved plan since July 2013. 10,929 of these continue to be active.
- 8,220 active participants have not previously received disability support via State and Commonwealth government programs in the past.
- 196 participants have entered the Scheme in the June 2024 quarter and net participants leaving the Scheme are 47, reflecting active participant movements in and out of the Scheme and Australian Capital Territory.
- 738 plans have had reassessments this quarter.
- 234 access decisions have been made in the quarter, of which 199 met access and are still active.
- 18 (9.2%) of the new active participants this quarter identified as First Nations participants, taking the total number of First Nations participants in Australian Capital Territory to 502 (4.6%).
- 20 (10.3%) of the new active participants this quarter are Culturally and Linguistically Diverse (CALD) <sup>4</sup>, taking the total number of CALD participants in Australian Capital Territory to 1,045 (9.6%).

• The PSG metrics are based on the recommendations of the 2019 Tune Review. The NDIA commenced measuring performance against the PSG metrics prior to the legislation of the Participant Service Charter and Guarantee. On 30 March 2022, the NDIS Amendment (Participant Service Guarantee and Other Measures) Bill 2021 passed in both houses of Parliament, and received Royal Assent on 1 April 2022. It introduces changes that provide greater flexibility for participants and the NDIA to amend plans.

<sup>1</sup> From the March 2024 quarter, performance is being measured using the available data on processes and dates. Milestones are being built into the new computer system to improve the capture of performance data. Where the performance remains unavailable for this quarter, "n/a" has been substituted.

- Total annualised plan budgets at 30 June 2024 were \$791m and payments from 1 July 2023 were \$612m.
- Out of 3,958 active providers in the June 2024 quarter, 328 providers provided support to Agency-managed participants, 3,172 providers provided support to plan-managed participants and 1,435 providers provided support to self-managed participants.<sup>1</sup>
- Utilisation has been 76% from 1 October 2023 to 31 March 2024, compared with an adjusted national benchmark of 79%.
- There were no providers receiving more than 70% of payments.
- The average annualised plan budget<sup>7</sup> at the end of June for active participants is \$72,400 (\$427,300 for participants in Supported Independent Living (SIL) and \$50,500 for participants not in SIL).
- The average payment<sup>8</sup> for the 12 month ending 30 June 2024 is \$57,300 (\$391,100 for participants in Supported Independent Living (SIL) and \$37,100 for participants not in SIL).

<sup>1</sup> From the March 2024 quarter, the active provider number includes both registered and unregistered providers. A participant may have a combination of plan management types over time.

<sup>2</sup> The 'benchmark' in this analysis is the national average after adjusting for the proportion of participants in Supported Independent Living (SIL) in each service district and the length of time participants have been in the Scheme.

<sup>3</sup> The payment enquiries come from the Provider Portal, Participant Portal and NDIS App.

<sup>4</sup> Total annualised plan budgets refer to those in the current plans of active participants at the end of quarter.

<sup>5</sup> Total plan inflation consists of plan budget changes occurring at plan reassessment as well as changes occurring within a plan between reassessments.

<sup>6</sup> Socioeconomic status uses deciles from the ABS Index of Education and Occupation (IEO). A higher decile indicates that people residing in that area have a higher level of skills and qualifications on average. The socioeconomic equity metric is equal to the average annualised plan budget of participants residing in the top four IEO deciles divided by the average annualised plan budget of participants residing in the bottom four IEO deciles (participants not in SIL and aged 0 to 64).

<sup>7</sup> Average annualised plan budgets are derived from total annualised plan budgets in the current plans of active participants at 30 June 2024.

<sup>8</sup> Average payments are calculated as the average of the annualised monthly payments in the same 12 month period, weighted by the participants that are active in each month.
