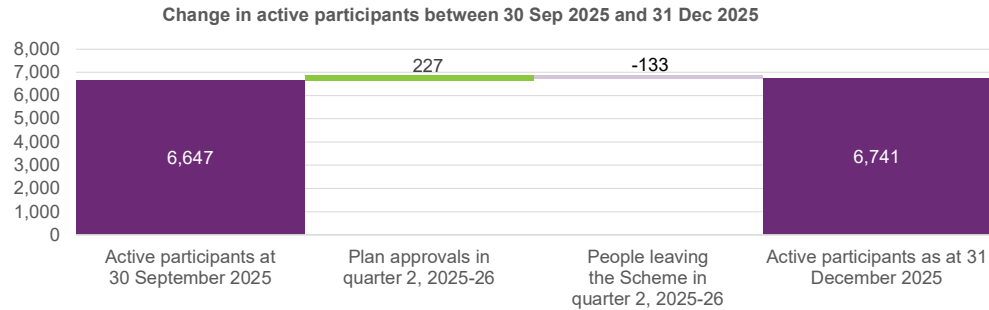

Performance summary:

- 7,886 participants (excluding children accessing early connections) have had an approved plan since July 2013. 6,741 of these continue to be active.
- 4,845 active participants have not previously received disability support via State and Commonwealth government programs in the past.
- 227 participants have entered the Scheme in the December 2025 quarter and net participants leaving the Scheme are 133, reflecting active participant movements in and out of the Scheme and Northern Territory.
- 284 access decisions have been made in the quarter, of which 223 met access.
- 129 (56.8%) of the new active participants this quarter identified as First Nations participants, taking the total number of First Nations participants in Northern Territory to 3,570 (53.0%).
- 7 (3.1%) of the new active participants this quarter are Culturally and Linguistically Diverse (CALD), taking the total number of CALD participants in Northern Territory to 342 (5.1%).

Reporting for PSG measures 3, 5 and 15 are not yet available and these will not be reported at this stage.

- Total annualised plan budgets at 31 December 2025 were \$935m and payments from 1 July 2025 were \$378m.
- Out of 2,515 active providers in the December 2025 quarter, 299 providers provided support to NDIA-managed participants, 2,078 providers provided support to plan-managed participants and 695 providers provided support to self-managed participants.
- Utilisation has been 74% from 1 April 2025 to 30 September 2025.

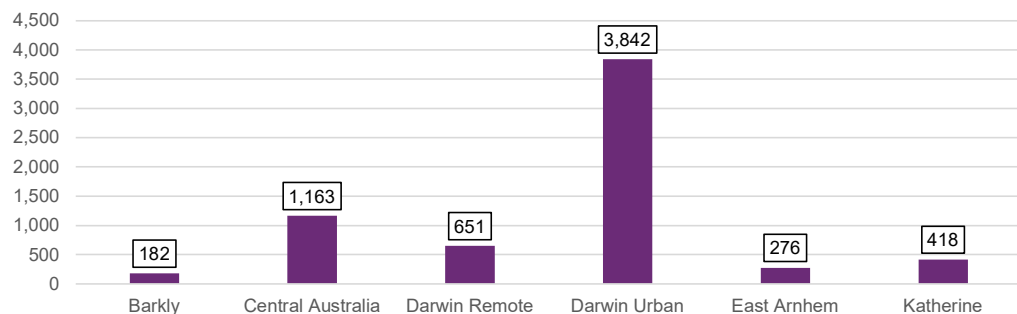

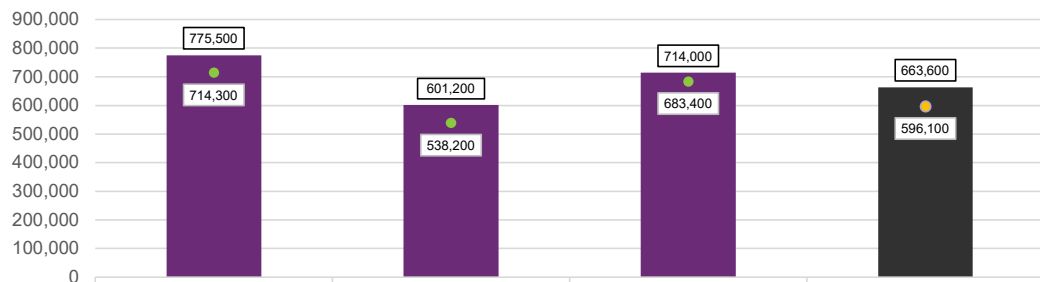

Active participants by service district ¹



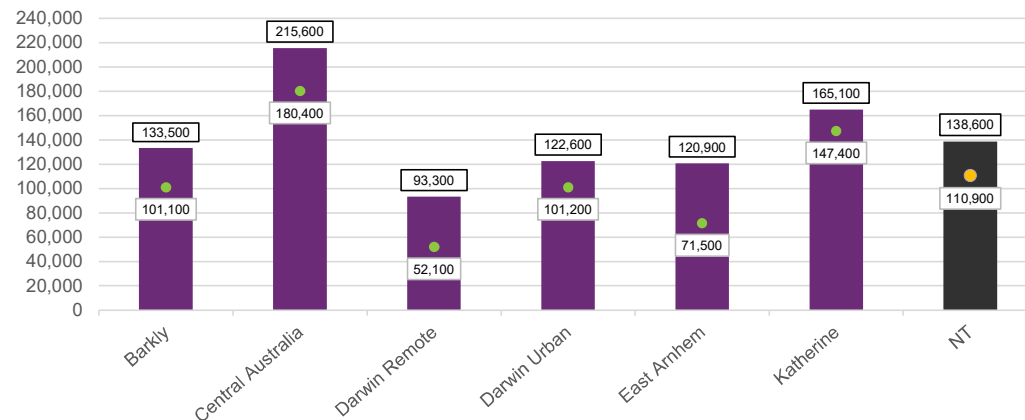
■ Active participants by service district as at 31 December 2025

Average annualised plan budgets and average payments - Participants in Supported Independent Living (SIL) (\$) ^{2 3}



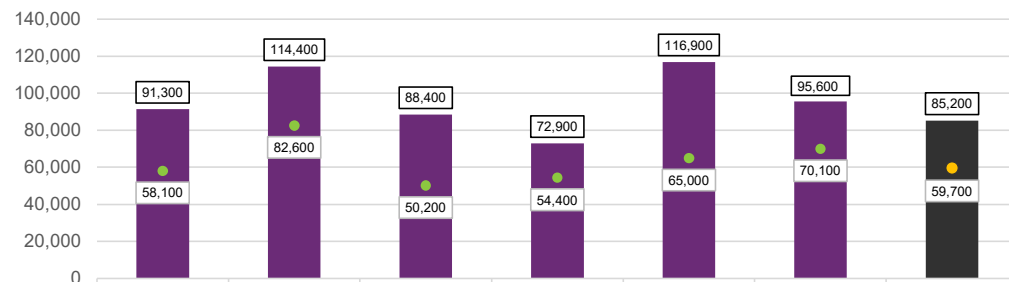
■ Average annualised plan budgets at 31 December 2025 ● Average payments for 12 months to 31 December 2025

- Darwin Urban has the highest number (3,842) of active participants, while Barkly has the lowest (182).
- The average annualised plan budget at the end of December for active participants is \$138,600 (\$85,200 for participants not in SIL and \$663,600 for participants in SIL).
- The average payments for the 12 months ending 31 December 2025 are \$110,900 (\$59,700 for participants not in SIL and \$596,100 for participants in SIL).
- Central Australia has the highest average annualised plan budgets and payments across all participants.

Average payments are calculated as the average of the annualised monthly payments in the same 12 month period, weighted by the participants that are active in each month.
