The NDIA appreciates the work of the Joint Standing Committee on the NDIS, and welcomes evidence based insights and reviews, which ultimately help the NDIA deliver a better service to participants.

The Government will respond formally to the recommendations, noting that work is already underway by the NDIA to improve AT processes.

The NDIS is a world-first, once in a generation reform – the biggest since the introduction of Medicare. The size and scale of the NDIS means that it will not be without challenges and the NDIA is committed to identifying and improving processes as the Scheme continues to roll out across Australia.

The NDIA recognises the transformative power of appropriate AT and has been working to ensure participants have access to individualised AT solutions that enhance their economic and community participation.

The NDIA has identified areas of AT implementation and delivery that require improvement. This aligns with feedback from participants and the sector.

The NDIA takes this feedback seriously, and acknowledges that more needs to be done to improve the timeliness and quality of AT decision making.

A program of work is underway to improve processes for the assessment and delivery of AT.

The NDIA is committed to delivering a better AT experience for participants and providers. The NDIA:

1. Has implemented immediate improvements to the planning process including reducing the need for quotes for all AT, and eliminating the need for quotes for low cost AT;
2. Has established dedicated resources to address outstanding AT plan approvals;
3. Will strengthen its support for timely AT repairs and replacements by including appropriate funding in plans;
4. Will pilot a new process to improve the assessments and timeframes for more complex and non-standard AT. The new pathway design will draw on the experience of specialised assessors who will work with participants and the NDIA during planning; and,
5. Will continue to engage with state and territory AT programs to identify opportunities for delivering improved AT outcomes to participants.

Previously, multiple professional assessments and quotes, as well as internal technical advice were required to implement most AT requests. The NDIA has a series of improvements designed to make the AT process simpler, easier and quicker. These improvements are outlined below.

4	AT Replacements	1. Replacement items (particularly like-for-like) are approved without needing re-assessment and will only require one quote	February 2019

6	Complex and non-standard AT	<ol style="list-style-type: none"> <li>1. Specialised Professional Panel engaged to conduct consistent and timely AT assessments.</li> </ol>	Pilot Panel in place: April 2019
