## Pricing updates - announced 1 October 2024

Starting from 1 October 2024, under certain circumstances, providers will be able to claim Intensive and Complex Behaviour Supports at the same price limit as High Intensity Supports.

This change addresses concerns that arose when the term “challenging behaviours” was removed from the High Intensity Support definition in the Pricing Arrangements and Price Limits.

Providers offering these supports can claim the higher price limit:

- Assistance with Daily Life Tasks in a Group or Shared Living Arrangement
- Daily Personal Activities
- Participation in Community, Social and Civic Activities
- Group and Centre Based Activities

To charge for this support, providers must:

1. Provide behaviour support that are in line with participant's plans.
2. Be registered and assessed for Module 2A by 30 June 2025, or
3. Apply for registration (new or amended) with a completed Module 2A audit by 30 June 2025.

## **Pricing updates - announced 17 September 2024**

The NDIA have released a plain English version of the 2023-24 Annual Pricing Review (APR).

This is the first time we have published a plain English version of the APR.

The plain English version does not change any of the recommendations previously released to market in the 2023-24 APR.

## **Pricing updates - announced 28 June 2024**

The National Disability Insurance Agency (NDIA) has announced changes to National Disability Insurance Scheme (NDIS) pricing, ahead of proposed broader reforms that will strengthen the NDIS provider market.

The APR sets the maximum price limits that NDIS providers and health professionals are permitted to charge when providing services to NDIS participants.

This year, the key changes include the following:

- Fully implementing the Fair Work Commission's decision to increase minimum wages in awards and superannuation, ensuring providers can fairly compensate their workers.
- Increasing price limits for supports that are determined by the NDIS DSW Cost Model, including Level 1 support coordination services, to reflect changes in the minimum wages following the Fair Work Commission's Annual Wage Review.
- Increasing the price limits for psychologists, nurses and other supports based on how much wages and the cost of living have gone up.

- Maintaining existing pricing arrangements and price limits for therapy (except for psychologists) and support coordination level 2 and 3.
- Adjusting short-notice cancellation period for non-Disability Support Worker-related supports to 2 business days to better reflect market norms.

The plans of NDIS participants will be adjusted starting in July, with funding being indexed on 13 July to account for these pricing changes.

## **Pricing updates - announced 18 April 2024**

### **Temporary Transformation Payment (TTP) Ending 30 June 2024**

The Temporary Transformation Payment (TTP) for disability support worker-related supports will end on 30 June 2024.

Providers will no longer be able to claim the TTP loading for services delivered on or after 1 July 2024.

Providers are encouraged to update their billing, invoicing, and record-keeping systems to reflect standard support item prices. Also, providers should review and adjust service agreements with participants as needed, ensuring clear communication about the TTP ending.

For Claims related to TTP services delivered on or before 30 June 2024, refer to the Legacy Support items tab of the Support Catalogue.

## **Pricing updates - announced 16 April 2024**

We have published an updated [Pricing Arrangements for Specialist Disability Accommodation \(SDA\) 2023-24](#) and [SDA Price Calculator 2023-24](#).

### **Maximum reasonable rent contribution (MRRC) and maximum board amount**

- Effective from 20 March 2024, the fortnightly MRRC has increased:
  - to \$463.75 for a single person (an increase of \$8.29)

- to \$296.31 for each member of a couple (an increase of \$5.28).
- Effective from 20 March 2024, the fortnightly maximum board contribution has increased:
  - to \$524.40 for a single person (an increase of \$9.05)
  - to \$395.25 for each member of a couple (an increase of \$6.80).

Providers must honour existing service agreements with participants and ensure they are compliant with Appendix I - SDA Terms of Business from the Pricing Arrangements for SDA 2023-24.

## Key pricing changes effective 1 January 2024

As of 1 January 2024, the transitional period for group and centre-based pricing is now complete.

This transition period commenced in July 2019 and concluded on 31 December 2023, allowing providers to move from ratio-based pricing to a fairer and more transparent pricing for group-based supports.

The ratio-based support items have been permanently removed from the NDIS Pricing Arrangements and Price Limits and moved to the Legacy tab of the NDIS Support Catalogue.

Providers must use the [Bulk Payment Request Template](#) for services delivered in arrears before 1 January 2024.

Services delivered after that date will be rejected by the payment system.

Starting 1 January 2024, all claiming for group and centre-based supports under Assistance with Social and Community Participation must follow the updated pricing arrangements.

## Pricing updates - announced 28 November 2023

We have updated the [Pricing Arrangements and Price Limits](#) document to clarify and improve arrangements for some travel costs.

### Assistance with daily life and supported independent living

We have included extra support items for Provider Travel – Non-labour costs. This allows participants to utilise the support from their Core budget in cases where Capacity Building funds are not flexible.

In support of this change, we have updated the [NDIS Support Catalogue](#) with new item numbers and descriptions.

### General transport

We have updated a few words, to clarify that this support item allows a participant to pay a provider to transport them to an activity. This could include an activity that is not itself a support. It also includes supports delivered by another provider.

## Pricing updates - announced 14 August 2023

We have released an updated PAPL with revised wording to provide more clarity for providers of group-based supports and supported independent living.

### Group-based supports

The update explains that providers can gradually transition participants as part of a group or centre-based support in stages. This means different groups of participants can transition at different times, which may align better with typical events such as end of program or service agreements.

### Supported independent living

Following the annual indexation of a participant's plan, providers can liaise with participants about the adjusted remaining SIL funds. If the participant agrees, providers can adjust the

weekly claim amount based on the number of weeks remaining in the plan and total plan funding available for SIL.

## Key pricing changes effective 1 July 2023

### Disability Support Worker (DSW) and related supports

- An extension of the temporary loading for a further 12 months at 1% from 1 July 2023. This temporary loading will cease from 1 July 2024.
- Inclusion of paid family and domestic violence leave into the DSW Cost Model. As a result, price limits will increase by 0.1%.
- Passing on the increase in Superannuation Guarantee Charge of 0.5% in full.
- Increased price limits for supports that are determined by the NDIS DSW Cost Model to reflect any changes in the minimum wages specified in the Social, Community, Home Care and Disability Services Industry Award 2010 (SCHADS Award) following the Fair Work Commission's National Minimum Wage Review.

### Therapy supports

- After extensive market analysis and consultation, there will be no adjustment to the pricing arrangements and price limits for therapy supports on 1 July 2023.
- The market for therapy continues to attract new providers entering the market. Results from extensive benchmarking analysis suggest the current NDIS price limit of \$193.99 is above the average fully loaded hourly cost of most types of therapy professionals.
- Comparison to other government therapy schemes and private billing rates suggest that NDIS price limits for therapy supports remain competitive, with the NDIS price limits remain in the middle or upper range for most therapies.
- We have invested significantly in the therapy market, with the amount claimed rising by 26% to \$1.6 billion over the six months to December 2022, compared to the six months to December 2021.

### Support coordination and plan management supports

- Level 1 support coordination will be indexed in line with the indexation of supports determined by the NDIS DSW Cost Model.
- After careful market analysis and consultation, there will be no adjustment to the pricing arrangements and price limits for support coordination level 2 and 3.
- After careful market analysis and consultation, there will be no adjustment to the price limits of plan management supports. The growth of participants and providers of plan

management supports over the past two years suggests this market is still viable.

- We have invested significantly in the markets for support coordination (amount claimed rose by 15% to \$428 million) and plan management (amount claimed rose by 14% to \$228 million) over the six months to December 2022, compared to the six months to December 2021.
- The NDIA looks forward to working closely with the sector and individual support coordinators to develop a better understanding of worker composition and cost structure.

## **Other Supports**

- The price limit for Other Supports will be increased by 4.36% from 1 July. The rate is calculated by combining 80% of the movement in the ABS Wage Price Index (3.7%) and 20% of the movement in the ABS Consumer Price Index (7%) over the 12 months leading up to the March quarter preceding the indexation date.

## **Temporary Transformation Payment (TTP) Loading**

- Maintain the scheduled reduction in the TTP loading to 1.5%. The TTP Loading will cease from 1 July 2024.

## **Pricing updates - announced 16 June 2023**

The Annual Pricing Review (APR) is important to regularly review pricing arrangements and price limits to ensure participants can access high quality supports while also receiving value for money.

This year, the price limits for supports delivered by disability support workers will be adjusted on 1 July 2023 by 5.3% to account for:

- The Fair Work Commission's (FWC) National Minimum Wage decision to increase minimum award wages by 5.75%. This change will also come into effect for Level 1 Support Co-ordinators.
- An extension of the temporary loading for a further 12 months at 1% from 1 July 2023 with this ceasing on 1 July 2024.
- Inclusion of paid family and domestic violence leave into the Disability Support Worker Cost Model - increase by 0.1% from 1 July to reflect the new entitlements for workers in the industry.
- Passing on the increase in Superannuation Guarantee Charge of 0.5% in full.

After careful market analysis and consultation, there will be no adjustment to the pricing arrangements and price limits for therapy, plan management and support coordination levels 2 and 3.

The plans of NDIS participants will be adjusted from July, with funding to be indexed on 10 July to account for these pricing changes.

## **Pricing updates - announced 5 May 2023**

### **Extension of Group-based Supports (GBS) Transition**

We are extending the transitional pricing arrangements for group-based supports until 31 December 2023.

This allows providers additional time to successfully transition to the new pricing arrangement, which will be further supported through the release of provider guidance.

### **Clarifying claiming of Non-Face-to-Face Supports**

Under the new pricing arrangement, providers and participants have more flexibility to agree on non-face-to-face support fees that reflect the cost of meeting the individual participant's need for a group-based support.

These changes will allow providers to develop more averaged approaches to charging non-face-to-face support costs, reducing administrative burden, and are in response to feedback received through extensive consultation undertaken with the sector in late 2022.

The fee charged for non-face-to-face supports must be reflective of the needs of the participant in the group-based support and requires providers to agree the non-face-to-face support costs with a participant upfront, to ensure a participant has transparency of these costs.

### **Increasing maximum duration of Programs of Support from 12 weeks to 6 months**

From 5 May 2023 the maximum duration of programs of support was extended from up to 12 weeks to up to 6 months.

While some participants and providers will welcome the option to move to longer Programs of Support, the NDIA reiterates that this is a maximum length and shorter Programs of Support can still be agreed between participants and providers if preferred.



## Extension of subscription claiming to flexibly provided high cost assistive technology (AT)

From 5 May 2023 flexible packages of high cost AT, particularly for participants with changing needs, can use an extension to subscription claiming rules.

For packages of high cost assistive technology (AT) (05 budget category), the claiming limit for a subscription is set at \$10,000 per year. All the conditions listed for subscription services apply.

Participants/providers can only claim the increased subscription limit where the total value of the assistive technology available and supplied through the AT package costs \$15,000 or more.

The package value is based on the market purchase price of the items that make up the package provided.

## Updates to NDIS Pricing Arrangements for SDA 2022-23

Effective 20 March 2023, the NDIA has published an updated Pricing Arrangements for Specialist Disability Accommodation 2022-23 and SDA Price Calculator 2022-23.

- We have updated the maximum reasonable rent contribution (MRRC) and board amounts in line with increases to the Disability Support Pension. Changes are effective from 20 March 2023.
- Effective 20 March 2023, support item 06\_434\_0131\_2\_2, Specialist Disability Accommodation Monthly Amount will be removed from NDIS Pricing Arrangements for SDA 2022-23.
- Under Appendix G, the pricing arrangements for SDA and SDA Calculator now include annual base prices SDA eligible participants who live in shared living arrangements including people who are not SDA-eligible.

## Pricing updates - announced 4 October 2022

### Inclusion of portable air purifiers as a COVID-19 low cost AT item

From 1 October 2022, eligible participants can use existing [low cost AT processes](#) to purchase a portable air purifier for personal use as a time-limited COVID-19 support measure.

## Adjustments to COVID-19 workforce support arrangements

In line with the intent and duration of the program, the [Winter Relief Workforce](#) (WRW) support measure ends on 30 September 2022.

## Changes to SIL Additional Supports measure

From 1 October 2022, the supported independent living (SIL) Additional Supports payment will be changed from \$1200 per participant per day back to \$1200 per household per day.

SIL Additional Supports payments are provided to SIL providers who support SIL participants who are required to self-isolate or quarantine due to state/territory government health orders.

Current service booking and claiming arrangements are unchanged for eligible providers.

To simplify processes, a single direct billing claim (instead of multiple claims) can be made in addition to the usual claim that providers make for the provision of Assistance in SIL supports for individual participants in the same household. The [COVID-19 Addendum](#) has been updated effective 1 October 2022 to reflect the changes to payment of SIL additional supports.

These changes are in line with public health orders being relaxed across all states and territories.

## Pricing updates - announced 30 September 2022

The NDIA released an updated [NDIS Pricing Arrangements and Price Limits and Support Catalogue 2022-23](#).

Key updates:

- clarifying language on some early childhood terms to support [ECEI reset](#) recommendations. We've also included a reference to the [NDIS Practice Standards and Quality Indicators](#), which apply to professionals specifically relevant to early childhood supports.
- an [addendum](#) for the new SIL support item to specifically support the implementation of the [Home and living demonstration](#) projects for use by NDIS providers with a Memorandum of Understanding to deliver the Round 1 demonstration project.
- introduction of a new SDA support item to help eligible participants living as sole occupants in SDA-enrolled dwellings where onsite shared support arrangements are in place.
- new minor home modification claiming codes, with a nominal \$1 value, for providers to use in service bookings (where applicable) and claims against a participant's approved budget. ## **Pricing updates - announced 23 August 2022**

### **Extension of vaccination support measures and changes to RAT claiming for SIL**

COVID-19 vaccine enablement payment for participants and booster payment for disability support workers have been extended to 31 December 2022.

Eligible providers in the following registration groups can claim \$75 per participant, per dose to receive any COVID-19 vaccination:

- 0104 High Intensity Daily Personal Activities
- 0106 Assistance in Coordinating or Managing Life Stages, Transitions And Supports
- 0107 Daily Personal Activities
- 0115 Assistance with Daily Life Tasks in a Group or Shared Living Arrangement
- 0125 Participation in Community, Social and Civic Activities
- 0127 Management of Funding for Supports in Participants' Plans
- 0133 Specialised Supported Employment
- 0136 Group and Centre Based Activities

Eligible providers in the following registration groups can claim \$100 per worker for a COVID-19 vaccine or booster:

- 0104 High Intensity Daily Personal Activities
- 0107 Daily Personal Activities
- 0115 Assistance with Daily Life Tasks in a Group or Shared Living Arrangement
- 0125 Participation in Community, Social and Civic Activities

Between 23 December 2021 and 31 August 2022, eligible SIL providers were able to claim \$12.50 for a rapid antigen test (RAT) when a support worker needs to undergo COVID-19 testing to deliver supports, based on state or territory public health recommendations or requirements.

This temporary support measure is finalised effective 31 August 2022.

## **Pricing updates - announced 22 June 2022**

From 1 July 2022 we are increasing price limits for services delivered by disability support workers by 9% to address known cost pressures on providers, including:

- changes to the Social, Community, Home Care and Disability Services (SCHADS) Industry Award conditions that will come into effect on 1 July 2022
- costs associated with managing the COVID-19 pandemic
- NDIS quality and safeguards regulatory requirements
- Fair Work Commission's recent wage decision
- superannuation guarantee charge increase.

The Annual Pricing Review showed the cost of delivering core supports was higher than anticipated during 2021-22, as a result of the impact of COVID-19 and quality and safeguarding requirements.

The NDIA will also make up to an extra \$514 million available to providers to recognise costs of keeping participants safe, particularly during the COVID-19 pandemic, and the significant overhead costs incurred by registered providers of activities of daily living and community participation supports not previously taken into account.

## **NDIS Disability Support Worker Cost Model**

We have updated the NDIS Disability Support Worker Cost Model to better reflect the cost structures of efficient providers in the sector.

From 1 July 2022 we are increasing price limits for supports delivered by disability support workers by 9%. This includes:

- 1.7% increase to base prices
- 2% temporary loading, reviewed annually
- 4.6% increase in award minimum wages
- 0.5% increase to superannuation guarantee charge

The NDIS Disability Support Worker Cost Model determines the price limits of assistance with activities of daily living and social, community and economic participation supports (and of some capacity building supports).

## **Simplify NDIS price control framework**

We have updated the NDIS Pricing Arrangements and Price Limits to clarify a High Intensity support as a support provided to a person:

- who needs frequent (at least one instance per shift) assistance to manage challenging behaviours that require intensive positive behaviour support, and/or
- who has support needs that require the skills described by the NDIS Commission as “High Intensity Daily Personal Activities”.

We have introduced a single price limit for High Intensity supports (varying by time of day and day of week), set at the previous Level 2 price.

## **Provider travel**

We have updated the NDIS Pricing Arrangements and Price Limits so the pricing arrangements for provider travel is the same for providers of core supports to participants in remote and very remote areas as for providers of capacity building supports.

Providers of core supports will also be able to claim for return travel in certain circumstances.

## **Group based community participation supports**

As we [previously announced in April 2022](#), we are extending the transitional pricing arrangements for group based core supports until 30 June 2023 to allow providers more time to adjust to the pricing arrangements introduced on 1 July 2020.

## Temporary Transformation Payment arrangements

As planned, the Temporary Transformation Payment (TPP) loading will reduce to 3.0% from 1 July 2022 and then to 1.5% on 1 July 2023 and then 0% from 1 July 2024.

## Therapy Supports

The price limits for therapy supports will be maintained at the 2021 price limits. Further work will be conducted to review therapy price limits.

Specific line items for other therapists: 'other therapists' is defined as a person who is not one of the types of therapists specifically listed but who the provider considers to be an appropriate professional to deliver therapeutic supports in line with the NDIS Quality and Safeguarding Commission's requirements for the Therapeutic Supports Registration Group.

## Early Childhood Intervention Supports

Specific line items for other professionals: 'other professionals' is defined as a person who is not one of the types of professionals specifically listed but who the provider considers to be an appropriate professional to deliver supports in line with the NDIS Quality and Safeguarding Commission's requirements for the Early Intervention Supports for Early Childhood Registration Group.

There have also been minor support item name changes to Early Childhood Intervention Supports.

## Nursing Supports

The price limits for nursing supports will be indexed on 1 July 2022 in line with the Wage Price Index and Consumer Price Index.

## Support Coordination

Support coordination price limits will be maintained at 2021 levels for the following supports at this time:

- Level 2: Coordination of Supports
- Level 3: Specialist Support Coordination.

The price limits for support coordination will be maintained at the 2021 price limits while further in-depth reviews are completed. Further information on this will be released shortly.

Level 1 support coordination supports will be indexed in line with other supports whose price limits are determined by the DSW Cost Model.

## **Plan Management**

The price limits for plan management will be maintained at the 2021 price limits while further in-depth reviews are completed. Further information on this will be released shortly.

## **Specialist Disability Accommodation**

We are introducing a new SDA line item from 1 July 2022 to ensure providers have an easier way to claim for services delivered to participants.

A second SDA line item has been created in the SDA Pricing Arrangements.

The new SDA line item means providers can complete service bookings for participants living in SDA enrolled dwellings.

This removes the need for the NDIA to complete the service bookings on the participant's behalf.

The existing SDA (quote required) line item will continue to be used for participants not yet living in SDA dwellings.

## **Regional, remote and very remote area supports**

From 1 July 2022, locations that are not classified as remote or very remote under the Modified Monash Model (MMM) will be classified as remote for planning and pricing purposes if it is not possible to travel from the identified location to a major city, or other city of more than 50,000 people, without crossing a remote area.

For example, Geraldton in Western Australia, and its surrounding areas, will be treated as remote.

- We will maintain the current remote and very remote loadings for pricing and planning purposes.
- We will continue to use the MMM of geographical classification for planning and pricing purposes.

## New NDIS Bereavement Addendum

The new NDIS Bereavement Addendum lists support items that providers can claim after an NDIS participant has died.

The NDIS Bereavement Addendum is not a standalone document and must be read in conjunction with NDIS Pricing Arrangements and Price Limits.

There are two items in the current Addendum, one for plan managers and the other for supported independent living (SIL) providers to use in the event of a participant's death.

## Extension of COVID-19 booster payment for disability support workers

COVID-19 booster payment for disability support workers has been extended to 31 August 2022.

Registered providers in the following registration groups can claim \$100 per worker for a booster vaccination:

- 0104 High Intensity Daily Personal Activities
- 0107 Daily Personal Activities
- 0115 Assistance with Daily Life Tasks in a Group or Shared Living Arrangement
- 0125 Participation in Community, Social and Civic Activities

## Pricing updates - announced 26 May 2022

### Minor update to COVID Addendum

On 26 May 2022, the NDIA updated the [COVID Addendum](#) to remove the terms 'up to' for Supported independent living (SIL) supports and 'up to a fixed price of' for vaccines and Rapid antigen tests (RATs):

- Supported Independent Living (SIL) - Additional Support for SIL Participants who are required to self-isolate or quarantine - Direct Billing Arrangement
- Supported Independent Living (SIL) - Deep Cleaning when a SIL Participant is required to self-isolate or quarantine - Direct Billing Arrangement



- Deep Cleaning for Support Worker-Related COVID Diagnosis – Direct Billing Arrangement
- Enabling COVID Vaccinations for participants
- Rapid antigen testing for SIL support workers
- Enabling vaccination boosters for workers.

This administrative update aims to clarify the process in claiming direct billing items.

## **Pricing updates - announced 1 April 2022**

### **Changes and extensions to the participant COVID-19 vaccination enablement payments for providers**

From 1 April 2022, providers in the following registration groups can claim \$75 per participant per COVID-19 dose when they support a participant to receive their vaccinations:

- 0104 High Intensity Daily Personal Activities
- 0106 Assistance in Coordinating or Managing Life Stages, Transitions And Supports
- 0107 Daily Personal Activities
- 0115 Assistance with Daily Life Tasks in a Group or Shared Living Arrangement
- 0125 Participation in Community, Social and Civic Activities
- 0127 Management of Funding for Supports in Participants' Plans
- 0133 Specialised Supported Employment
- 0136 Group and Centre Based Activities

COVID-19 vaccinations eligible for this support include the primary vaccination dose, as well as any booster vaccination dosages.

Providers can claim the \$75 payment per participant per vaccination dosage delivered between 1 April and 31 August 2022.

Providers have 28 calendar days after 31 August 2022 to claim for this support.

This support replaces the following previous temporary supports:

- \$150 to assist a participant to receive their primary doses of the COVID-19 vaccination
- \$75 to assist a participant to receive their booster doses.

### **Rapid antigen test (RAT) expansion for support workers**

RAT claims for support workers have been extended until 31 August 2022.

This support was originally scheduled to end on 30 April 2022.

## Pricing updates - announced 30 March 2022

The NDIA has published an updated [Pricing Arrangements for SDA 2021-22](#) and [SDA Price Calculator 2021-22](#).

### Maximum reasonable rent contribution (MRRC) and maximum board

Maximum rent contribution and maximum board amounts have been updated to reflect the increases to the Disability Support Pension.

Effective from 20 March 2022, the fortnightly maximum reasonable rent contribution has increased:

- to \$389.18 for a single person (an increase of \$8.03)
- to \$252.15 for each member of a couple (an increase of \$5.17).

Effective from 20 March 2022, the fortnightly maximum board contribution has increased:

- to \$464.50 for a single person (an increase of \$9.30)
- to \$350.10 for each member of a couple (an increase of \$7.00).

Providers must honour existing service agreements with participants and ensure they are compliant with Appendix H - SDA Terms of Business from the [Pricing Arrangements for SDA 2021-22](#).

### SDA multi-design category dwellings

The Pricing Arrangements for SDA 2021-22 now includes information on [SDA multi-design category dwellings](#), and how they are priced.

The pricing for an SDA dwelling with multiple design categories reflects a maximum price per participant, for each design category.

We price individual bedrooms separately and take into account the total number of residents/bedrooms in the dwelling.

For example, in a group home of 4 residents (each with their own bedrooms), where two bedrooms meet the High Physical Support design category and two bedrooms meet the Improved Liveability design standard:

- the two Improved Liveability bedrooms are each eligible for the per participant, Group Home, 4 resident, Improved Liveability price; and,
- the two High Physical Support bedrooms are each eligible for the per participant, Group Home, 4 resident, High Physical Support price.

If an SDA provider has enrolled a multi-design category dwelling that includes Robust category bedrooms and a breakout room, then the additional price for the breakout room is added to the base price of the per participant price for each bedroom of the Robust design category only.

## **Pricing updates - announced 1 March 2022**

### **Meal preparation and delivery - ongoing flexibility in our guidelines**

Effective 1 March 2022, NDIS participants who usually have a support worker help them prepare meals at home or help with grocery shopping, can flexibly use these funds to pay for prepared meals and delivery support in certain circumstances.

This was made clear in [our guidelines](#) for Nutrition Supports including meal preparation published on 28 February 2022.

A new support item has been added to the pricing arrangements 01\_023\_0120\_1\_1: Assistance with the cost of preparation and delivery of meals.

Providers will no longer need to submit quotes for meal preparation and delivery supports included in new plans from 1 March 2022, however a participant must have this support included in their plan for a provider to be able to claim. This does not impact existing plans.

### **Mid cost assistive technology (AT)**

New support items for AT have been included in the support catalogue to support the changes that expand mid cost AT to cover AT valued between \$1,500 and \$15,000 and changes to

### **Booster vaccination payments for disability support workers**

Effective 1 January to 30 June, providers in the following registration groups can claim \$100 per worker to receive a booster vaccination:

- 0104 High Intensity Daily Personal Activities
- 0107 Daily Personal Activities
- 0115 Assistance with Daily Life Tasks in a Group or Shared Living Arrangement
- 0125 Participation in Community, Social and Civic Activities

## **Rapid antigen test (RAT) expansion for support workers**

RAT claims for support workers have been extended until 28 February 2022. This support was originally ending on 31 January 2022.

## **Direct claiming for additional SIL supports between 11 January and before 7 February 2022**

Additional SIL supports delivered between 11 January and before 7 February can be claimed through the direct claiming process using the bulk payment request template.

Providers should use a claim date of 7 February to ensure a successful claim.

Direct claiming for additional SIL supports that include a date before 7 February will not be processed.

## Pricing updates - announced 17 January 2022

### Expansion of COVID-19 vaccination and booster enablement payments for providers

From 17 January 2022, providers in the following registration groups can claim the COVID vaccine and booster enablement payments if they support a participant to receive their vaccinations:

- 0133 Specialised Supported Employment
- 0136 Group and Centre Based Activities

Providers must claim for the payments within the following dates:

- \$150 COVID-19 vaccination payment by 31 March 2022
- \$75 COVID-19 booster vaccination payment by 30 June 2022.

## Pricing updates - announced 13 January 2022

### Expansion of temporary COVID-19 arrangements for meal preparation and delivery supports

From 12 January 2022 to 28 February 2022, NDIS participants with Core funding for support worker hours to help with meal preparation or shopping can now flexibly use their Core supports budget to pay an external provider for meal preparation and delivery, instead of paying a support worker to assist them with these tasks at home.

This arrangement is available across all states and territories.

## Direct claiming for SIL cleaning services and additional SIL supports

From 7 February 2022, providers can directly claim for cleaning services and additional SIL supports for participants with additional needs because they are directed to self-isolate or quarantine from the relevant state/territory government or Australian Government due to COVID-19.

The 2 support items are:

- up to \$300 for one-off deep-cleaning services when they are required as a result of COVID-19
- up to \$1200 per participant, per day for additional supports if you are required to self-isolate as a result of COVID-19.

## Direct claiming for support worker-related COVID diagnosis

From 7 February 2022, if a support worker attends a participant's home who later tests positive to COVID-19, providers can claim up to \$300 per professional deep clean directly from the NDIA.

Any professional deep cleans that happen before 7 February 2022, can be paid for from the participant's plan.

Instructions about how to claim this support will be emailed directly to providers and published on the NDIS website by 7 February 2022.
